November 9th, 2018 - May 2018 is to adopt accountability measures to achieve greater security and trust around processing The principle of accountability pervades all of the primary obligations of controllers under the GDPR and the objective is to implement a holistic compliance programme for their data processing activities

November 9th, 2018 - Under the new GDPR this approach is preferred over the traditional notification obligation The EU legislature tries to heighten data controllers' accountability by replacing the notification obligation with alternative obligations
